The undersigned parent or guardian consents to the participation of his or her above named child or ward (“wrestler”) in the Wichita Wrestling Club, Inc. (“WWC”) program and releases, discharges and waives any and all claims, actions, demands or rights arising or resulting from or in connection with the wrestler’s participation in the WWC program or competing as a team member.

This release, discharge and waiver shall bind, and is on behalf of the wrestler, his parents and representatives and shall extend to and include Wichita Wrestling Club, Inc., Kapaun Mt. Carmel High School, the Wichita Catholic Diocese and their coaches, agents, officers, representatives and members. In addition, this release and waiver shall extend to all schools, other wrestling clubs, or associations, wrestling leagues or wrestling officials.

This release, discharge and waiver shall include any injury sustained by the wrestler while at or during training or practice sessions, matches, tournaments, or other activities arranged by or through WWC; and, in addition, while traveling to or from such matches, tournament or activities.

The undersigned agrees that in the event the wrestler is not bound by this release, discharge and waiver, and that if any of the organizations or persons named herein shall consequently be held liable to the wrestler or others for any damage, loss, or expense otherwise released herein, then in such event, the undersigned agrees to indemnify such person or organization in the full amount for which they were found liable together with all related reasonable expenses, fees, and costs incurred by such person and organization.

The undersigned understands that the annual membership fee in WWC is not refundable and the WWC coaches and staff will be the sole and final authority as to the continued participation of its members. Included in the annual fee is membership in USA Kansas Kids Wrestling and, in some cases, coverage under the hospital and medical insurance plan of USA Wrestling for those minor participants who qualify for such coverage. WWC will supply competition uniforms (no shoes or headgear) and the entry fees for all events up to the Sub-District Championships. It is understood that all travel expenses, food and lodging, and entry fees for events including and following the Sub-District Championships will be in addition to the annual membership fee.

The annual fee for the 2011/2012 Season will be \$210.00 for Novice wrestlers and \$250.00 for Open wrestlers. The fee is attached to this waiver.

Wichita Wrestling Club, Inc. urges parents to have their child checked by the family doctor prior to practice. Parents assume the responsibility for the child being physically able to compete.
